

DATE: March 11, 2012 @ 12:02 pm

MODERATORS: Pastors Morgan Wong and Allen Ye

ATTENDANCE: 65

1. WELCOME, OPENING PRAYER, HYMN (The Church's One Foundation) AND SCRIPTURE (Eph. 4: 1-7) conducted by both pastors.

2. BUSINESS

- A. ELECTION OF RECORDING SECRETARY, Bernice Hills. Linda Con moved, Peggy Chow seconded. Carried. (M/S/C)
- B. ADOPTION OF AGENDA Ada Con moved, John Con seconded, Carried.
- C. ADOPTION OF 2011 AGM MINUTES Athena Chu moved, Jeanette Lee seconded, Carried.
- D. FINANCIAL REPORTS
 - a. 2011 Treasurer's Report Ken Shuen moved, Garland Chow seconded, Carried.
 - b. 2011 Financial Review Ken Shuen moved, Garland Chow seconded, Carried.
 - c. 2012 Proposed Budget John Con moved, Holly Siu seconded. Richard Wong asked about the reduction in kindergarten and manse rental revenues. Ken Shuen answered the kindergarten will be discontinued this fall. Morgan asked George Hui about the manse and he replied the rental revenue is reduced in anticipation of the sale of the manse. Carried.

E. LISTING OF CHURCH MANSE:

Allen re-read the 1996 recommendation that was passed. Today's motions:

MOTION 1: To list the Manse for sale with a minimum listing value of \$1,300,000. Garland Chow moved and Victor Ling seconded.

Discussion: Deanna Wong asked for what would the proceeds of the manse be used. Morgan replied it would be used to buy either lot but right now the motion is only to list, not sell. Grace Wong asked about the 1996 motion being fulfilled. Morgan replied the duplexes were bought without the sale of the manse. Grace Wong asked what was the 2007 motion. Allen put the 2007 motion onto the screen. Grace Wong questioned the sequence of the motions – why sell now if the other lots are not for sale and why not use a line of credit at no interest instead. Farrell Louie asked why sell the manse at the proposed price of \$1.3 million when we don't know the cost of the corner or 4th lot. Morgan replied the manse price will never equal the cost of any property on Cambie St. The sale will always result in a deficit to the potential purchase. Richard Wong asked if CPC succeeded in buying property without selling the manse in the past, why not wait until the corner lot is for sale. Morgan replied the motion is only to list the manse. Richard Wong asked why not list after we have a contract to buy the corner property. John Con answered that the main idea is to move now while there are still members with the passion, commitment and time to work on this mega project. Considering the aging congregation, there is a question of who would do the work in the future. Joanna Un commented that we have go through democratic rule and we have no idea of what the future will hold, like the Japanese earthquake. Grace Wong asked for the second motion to be moved before the first motion – that is that an offer be made before listing the manse. If the corner lot offer is accepted, then list the manse. George Sze said that the motion is about listing, not selling and it's all a concurrent motion and that the sequence is a minor issue.

Grace Wong amended the motion to say "list the manse for \$1.3 milion for the purposes of purchasing the corner lot or 4th lot at 49th and Cambie". Holly Siu seconded. George Sze said the Presbytery already approved 2007 motion and no changes are needed. Adrian Wong said Richard raises a good point about risk, but if God is directing us, then He'll take care of the risk.

Vote was taken on Grace's amendment: In favour: 14; Opposed: 17. Proposed amendment defeated.

Vote was taken on Motion 1 - In favour: 33; Opposed: 5. Motion carried.

MOTION 2: To allow the session to appoint a realtor the authority to make a fair offer on the corner lot at 49th & Cambie Street or on the 4th lot on 49th & Cambie Street.

Discussion: Grace Wong moved to amend Motion 2 to add "prior to the listing of the manse." Tim Tam seconded. John Con moved to amend the amended Motion 2 to change the work from "prior" to "concurrent". Joanna Un seconded. Garland Chow commented how we can make an offer when we don't know how much money we have. George Sze asked why amend a motion when the ultimate goal is still the same and said if it's God's will, we will have nothing to worry about. Tim Tam suggested we fast, then pray. Richard Wong said the corner lot owner called him. There's a possibility that the manse can be swapped with the corner lot and/or for future condo suites. George Sze said he's glad the corner lot owner is in contact with Richard. John Con withdrew his proposed amendment.

Vote on Grace Wong's amendment of adding "prior" - In favour: 17; Opposed: 21. Amendment defeated.

Vote on Motion 2 as originally listed - In favour: 24; Opposed: 0. Motion carried.

- F. Election of new members to the Board of Managers The terms of George Hui, Ying Wai Yeong and Nelson Chan are finished. All three have agreed to stand if re-elected. John Con moved to re-elect all three. George Sze seconded. Carried.
- G. Appointment of Treasurer Linda Sze was thanked for her past service and is re-appointed as the church treasurer for another year by the session.
- H. Election of Trustees Grace Wong moved to reappoint the same trustees. Remi Tam seconded. Carried.
- 3. Morgan announced various reports are listed in the Annual Report. Ada Con moved that all reports (Items 3 to 6 in the agenda) be adopted as printed in the 2011 Annual Report. Athena Chu seconded. Carried.
- 7. Other Business & Announcements Richard Wong asked where's the report on student enrollment that was mentioned in the 2011 minutes. Ken Shuen and Grace K.S. Wong replied it was done and circulated. Sue Mar thanked Ken Shuen for all his work. George Sze thanked Richard Wong's family for bringing up valid points in discussing the manse sale. Lela Ling moved that the AGM be adjourned. Garland Chow seconded. Carried.
- 8. Pastor Allen closed in prayer at 1:23 pm.

A WORD FROM THE PASTOR - "LIFE TOGETHER"

How good and pleasant it is when God's people live together in unity!

Ps. 133: 1

Indeed, it is not simply to be taken for granted that Christians have the privilege of living among other Christians. Jesus Christ lived in the midst of his enemies. At the end all his disciples deserted him. He was desperately alone, mocked by evildoers and died on the cross. For this cause he had come, to bring peace to humankind. So Christians, too, belong not in the seclusion of a cloistered life but in the swarm of foes with a purpose, sharing God's eternal love.

It is not an accident but purely by the grace of God that a congregation is sanctioned to gather and assemble visibly in this world to share God's Word and His love. Not all Christians receive this blessing. We know that visible fellowship is a blessing. It is grace, nothing but grace, that we are allowed to live in community with Christian brothers and sisters.

The physical presence of other Christians is also a source of incomparable joy and strength to the believers. The detained apostle Paul calls his dearly beloved son in the faith, Timothy, to come to him in prison in the last days of his life; he would see him again and have him near. Paul has not forgotten the tears Timothy shed when they last parted (2 Tim. 1:4).

The church theme for 2012 was "Life Together". Under this premise, our church continues to foster the community spirit by getting together in small groups, fellowship groups, home Bible studies, family fellowship, and Share & Prayer. In April, we started AWANA ministry welcoming children from ages three to nine. Nearly twenty children came on Saturday evenings, twice monthly, to have fun and to learn Bible verses. The Enoch Fellowship meets monthly on a Wednesday afternoon to discuss current topics and how to relate their faith to the world as believers.

We were very blessed to have Dr. Thomas Leung as the speaker for the Summer Conference among the Chinese speaking members. The theme this year was "New Life, New Commission." The Rev. Dr. Steve Tu was the speaker for the English speaking members. We were also very fortunate to have the Child Evangelism Fellowship of BC to run the children program for us. The convener of the organizing committee was elder Diana Wong. We had a large group of participants and learned a lot from the speakers. Praise God! The annual Vacation Bible School was once again headed by Lela Ling with numerous volunteers. In unity, they served joyfully in this ministry. More than forty children attended. The theme was "Trust God". The one-week program passed by swiftly; the students learned a lot of Biblical truths, and it was difficult to say good-byes in the end.

The Thursday afternoon Bible Study & Prayer group focused on the book of Genesis. Some members who worked during the day requested I to lead another evening Bible Study for them. We tried it for a few months until a few of them could not come and when I had to take over the English Ladies Bible Studies, this evening Chinese Bible Study came to a conclusion. In September, several members formed four groups of visitation teams to provide pastoral care to the shut-ins and reach out to the new comers on a monthly rotation basis. May God give them strength and compassion in this ministry.

It was a delight to see Bill Mah and elder Victor Ling heading up the Garden Club with numerous volunteers to beautify the front lawn and the back entrance of the church to make our property more welcoming.

As the Chinese saying goes, "There is no never ending banquet under the sun" (or "All good things come to an end"). After thirty-three years serving as the Preschool Principal, Grace Tong eventually retired last summer. We thank God for her faithful service and dedication to education. God provided Athena Chu, another faithful educator, as our new Principal. Also, Pastor Allen Ye said his good-bye to us in September, after serving in our congregation for four years, and moved on to another charge. May God continue to lead him and bless his ministries.

I thank God for our Session members for their spiritual leadership and wise decisions to oversee all activities and ministries smoothly. The Board of Managers, under the leadership of George Hui, demonstrated astute stewardship of God given resources to us. A word of appreciation to our church treasurer, Linda Sze, and elder Ken Shuen for all the financial works. There are many more devoted volunteers whom I can't name one by one here in this report. May God bless you all!

After one year of laboring, we had eight new members: Siu-Wah Lo, Yok Lo, Derek Dewald, Yuk Loon Yeong, and May Wong (by baptism); Elaine Wong (by confirmation); Yuk-Ying Chu and Yuk-Lan Yu (by transfer). May the Lord bless them with enriched spiritual life, faithfully trusting in Him and serving the Lord always. In the same year, nine members and adherents passed on and were united with Christ. As apostle Paul said, " 7 I have fought the good fight, I have finished the race, I have kept the faith. 8 Now there is in store for me the crown of righteousness, which the Lord, the righteous Judge, will award to me on that day—and not only to me, but also to all who have longed for his appearing (2 Tim. 4: 7-8)." In conclusion, May God bless all of you with His joy and peace. Amen.

TREASURER'S REPORT

Chinese Presbyterian Church continues to be strong financially. The 2012 Net Income will be transferred to the Designated Fund for Church Building Development.

This year, we received a larger than usual amount of special and designated donations which helped to substantially increase the total offerings for the year. Otherwise, general offerings remained static.

Nursery school enrollment fell in September, 2012 but the decrease in nursery school salaries alleviated the effect on net income.

We may have missed a good opportunity to sell the manse and build a new church mainly due to the lengthy debate about where the real estate market will go in the future and the setting of a selling price. Thus we received rental income for the full year on this property. We did not use the full 2012 budget for repairs to the church and the rental properties. This also contributed to the Net Income at the end of the year.

It is greatly appreciated for all those who continue to help out in accounting, finance and management: Ken Shuen, George Hui and Pearl Lee. Also a big thank-you to those who count the offering on Sundays: Garland Chow, George Hui, Pearl Lee and Yee Louis. We can always use a few extra helpers. The donation of your time can be a very valuable contribution.

REVIEW ENGAGEMENT REPORT

To The Members of Chinese Presbyterian Church

We have reviewed the statement of financial position of Chinese Presbyterian Church as at December 31, 2012 and the statements of changes in net assets and operations and cash flows for the year ended December 31, 2012. Our review was made in accordance with Canadian generally accepted standards for review engagements and, accordingly, consisted primarily of inquiry, analytical procedures and discussion related to information supplied to us by the Church.

A review does not constitute an audit and, consequently, we do not express an audit opinion on these financial statements.

Based on our review, nothing has come to our attention that causes us to believe that these financial statements are not, in all material respects, in accordance with Canadian accounting standards for not-for-profit organizations.

We draw attention to Note 4 to the financial statements, which describes that Chinese Presbyterian Church adopted the Canadian accounting standards for not-for profit organizatons on January 1, 2012 with a transition date of January 1, 2011. These standards were applied retrospectively by management to the comparative information in these financial statements, including the balance sheets as at December 31, 2011 and January 1, 2011 and the statements of operations, net assets, and cash flows for the year ended December 31, 2011 and related disclosures. We were not engaged to report on the restated comparative information, and as such, it is neither audited nor reviewed.

## NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED DECEMBER 31, 2012

#### (UNAUDITED)

#### 1. PURPOSE OF ORGANIZATION

The purpose of the Church is to provide a place to hold worship services, and to provide ministries for women, men, youth and children, preschool and pastoral care to those in need.

#### 2. BASIS OF PRESENTATION

These financial statements have been prepared in accordance with Canadian accounting standards for not-for-profit organizations.

#### 3. SIGNIFICANT ACCOUNTING POLICIES

The Financial statements have been prepared in accordance with generally accepted accounting principles summarized as follows:

#### **FUND METHOD ACCOUNTING**

The Church follows fund method of accounting.

The Congregation Fund accounts for the assets, capital receipts, and expenditures of the Church's operations excluding its trust liabilities.

The Designated Fund accounts for funds that have come to the Church through donations, bequests and by allocation from the Congregation Fund. They are internally reserved for specific purposes.

The Endowment Fund accounts for donations and bequests reserved for specific purposes. The unexpended income may be allocation to the Congregation Fund.

#### FINANCIAL INSTRUMENTS

The financial instruments of the Company consist mainly of cash, short-term deposits, accounts receivable, accounts payable and accrued liabilities, and long-term debt.

The carrying value of cash, term deposits, accounts receivable, accounts payable and accrued liabilities approximate their fair values due to their short maturities.

The fair value of the long-tem debts approximates its carrying value as the terms and conditions of the financing arrangements do not differ significantly from current conditions available for similar debt.

The Company has elected not to disclose fair value information about financial assets and liabilities for which fair value was not readily avaliable.

#### Credit risk:

The Church's accounts receivable are interest receivable. It is the management's opinion that the Company does not face credit risk.

#### Interest rate risk:

The Church's long term debt bears interest rate at the bank's prime rate. Changes in the bank's prime rate can cause fluctuations in interest payments and cash flows.

## NOTES TO THE FINANCIAL STATEMENTS FOR THE YEAR ENDED DECEMBER 31, 2012

In the year of acquisition only one-half the normal rate is applied.

#### REVENUE RECOGNITION

The Church recognized contributions as revenue when received or receivable. Revenue from nursery and Chinese school is recognized when srevices are rendered. Amounts received in excess of revenue recognized are presented as a deferred revenue liability.

#### **MEASUREMENT UNCERTAINTY**

The preparation of financial statements, in accordance with Canadian generally accepted accounting principles, requires management to make estimates and assumptions that affect the reported amount of assets and liabilities at the date of the financial statements and the reported amounts of revenues and expenses during the reporting period. These estimates are reviewed periodically and as adjustments become necessary, they are reported in earnings in the period in which they became known.

# 4. IMPACT OF THE CHANGE IN THE BASIS OF ACCOUNTING

The Company elected to apply the Accounting Standards for Not-for-profit Organizations, Part III of the Canadian Institute of Chartered Accountants (CICA) Handbook, in accordance with Canadian generally accepted accounting principles.

These financial statements are the first financial statements for which the entity has applied the Canadian accounting standards for not-for-profit organizations.

The financial statements for the year ended December 31, 2012 were prepared in accordance with the provisions set out in FIRST-TIME ADOPTION, Section 1501, of the CICA Handbook.

These standards have been applied retrospectively to the comparative information and had no impact on the opening equity balances at the date of the transition, January 1, 2011.

## 2012 Board of Managers Report Jan 31, 2013

In 2012, the Board thanks Ying Wai Yeong for acting as secretary, Ying Wai Yeong for handling IT and other issues, Nelson Chan for handling security and the photocopier issues, Daniel Lai for handling the telephone and internet service issues, Andrew Wong for representing the Board on the Property Development Task Force, and Linda Sze for managing CPC's financial matters. We also thank Reverends Wong and Ye for their guidance.

The BOM dealt with a number of issues in 2012, including the following:

- 1. The security system for the church was replaced and upgraded with a system from ADT thanks to the efforts of Nelson Chan and the generous donation of his time to evaluate bids from several other security system providers.
- 2. Board member Andrew Wong served on the Property Development and committee.
- 3. The telephone and internet service provider was changed to Shaw Cable Systems to reduce costs thanks to the efforts of Daniel Lai and the generous donation of his time to evaluate bids from several other photocopier system providers.
- 4. The configuration of the wireless network was updated to provide more reliable service through the church thanks to Nelson Chan and the generous donation of his time to reconfigure the network.
- The photocopier was replaced with a Kyocera copier to improve the reliability of the copier and to reduce costs thanks to the efforts of Nelson Chan and the generous donation of his time to evaluate bids from several other photocopier system providers.
- The blinds/curtains in the music room and nursery hall for the church were replaced thanks to the generous donation from the CPC Pre-School Parents.
- 7. A fire drill was organized and held on November 18, 2012.
- 8. The following facility improvements:
  - a. Air conditioner was repaired.
  - b. Holes under the heating vents behind the organ were sealed shut; weather sweepers/strips were installed on various doors throughout the church to address pest control issues.
  - c. Electrical outlets were inspected and repaired or replaced through the church. Light fixtures in the hallway were replaced.
  - d. Light fixtures in one of the classroom were repositioned to allow access to cabinets.
  - e. Routine maintenance was performed on the furnace.
- 9. The rental properties continue to be managed by VHL. All properties were rented in 2011. The Board decided to not increase the rents in 2012. The Board continues to follow the principle of incurring only those expenses deemed necessary for safety of the tenants and to permit the properties to be rented.

- 8. Repentance: It is God's desire for every one of us to repent of our sins. We will be subject to eternal punishment if we do not confess and repent. "I tell you, no, but, unless you repent, you will all likewise perish." Luke 13:3; "Those whom I love, I reprove and discipline; be zealous therefore, and repent." Revelations 3:19; Even though one may have been saved from one's sins, repentance must be ongoing.

All students in the class have demonstrated an eager and serious attitude towards learning God's Word. We exchange our ideas actively, and Mrs. Grace Wong is present to explain, answer, and facilitate our discussions. We hope to grow in our continued walk with God. Praise God in heaven.

Principal Grace Ng retired in August. She taught over 33 years at the Preschool. With God's guidance and her zeal to spread God's word through the children, the preschool grew from 8 students to 80 students. The parent committee and many alumni organized a grand fare well party at the Hyatt Hotel. 500 alumni, friends and family came to wish her fare well. Several of the younger alumni sang songs to her and students from 1990 onwards presented flowers to her. Many graduates before 1979 attended. Not only was it a wondrous celebration of Principal Grace's retirement but also a happy reunion for all those who attended CPC.

This September, the senior enrollment was less than previous years. Fortunately our junior numbers were good. We registered 40 students. # PROPERTY DEVELOPMENT TASK FORCE

¹Unless the LORD builds the house, the builders labor in vain.
Unless the LORD watches over the city, the guards stand watch in vain.
~ Psalm 127: 1 (NIV)

The Property Development Task Force (PDTF) is a sub-committee appointed by the session. It consists of seven members: elder George Sze (a member from Session), elder Adrian Wong (a member from the Trustees), Andrew Wong (a member from the Board of Managers), Kiat Chang (a member of the congregation with experience / knowledge in the construction, real estate business or financing), Linda Sze (the Church Treasurer), Pastor Allen Ye and Rev. Morgan Wong (convenor).

The mandate of the PDTF is to gather more information and make recommendations to Session as to what the next step(s) CPC could take with respect to developing of the properties. The PDTF is to determine if whether any "seed" money is required at this time, and if required, to establish a budget and identify the expenditure,... to further define our "focus/priorities," and to estimate/look into the possible costs of the various options and to report back to Session.

The PDTF had met ten times since the beginning of its inception in the fall of 2011 and throughout 2012. We revisited our church vision which is "to fulfill the Great Commission by invigorating and building upon the existing congregations, reaching out to the local community, and developing members and adherents through existing and future Christian education programs, with a long run vision of developing a private Christian school," to explore how our properties can materialize our vision and foster such growth.

We discussed different options for redevelopment and sought God's intention for us.

- 1. Retain the existing church location and work out a joint venture with Alliance Francaise to rebuild and share classroom facility.
- 2. Move CPC to a new site to build a new church with more classroom spaces and facilities.
- 3. Negotiate with a reputable developer to develop the duplex properties and provide us with the space that we required. We become a strata-owner. Sell off the old church and the manse. CPC will most likely be debt free with a new facility across from the Langara Canada Line Station.
- 4. Renovate our current church financed by selling some rental properties.
- 5. Consult with our congregation for other feasible options that match CPC Vision.

Some PDTF members met with the directors of Alliance Francaise to discuss the possibilities of redeveloping both our properties jointly. Unfortunately, the outcome was negative. We proposed to Session to sell our manse that the minimum listing price be 1.3 million dollars and Kiat Chang be our agent. This was accepted by Session and approved by the congregation. We further proposed to Session that Kiat to approach the owners of our adjacent duplex properties (lot 1 and lot 4) to negotiate a purchase price. As the housing market has slowed down in recent months, the manse has not been sold and the owners of lot 1 and lot 4 did not respond to our inquiries.

The PDTF asked permission from Session to engage an architect to conduct a feasibility study as a facilitator to interview user groups and examine church usages to identify with a possible area and parking requirements for our future church facility and it was approved. Currently, we have a few architects in mind and will select an appropriate one for our purpose.

We thank you for your prayerful support in this matter and together we seek God's direction for our future.

## **SUNDAY SCHOOL REPORT**

We praise and thank God for his continued direction and guidance over our Sunday School. Our staff consists of fourteen dedicated teachers and two substitutes who dedicate his/her time and commitment to share and model God's Word to children, youth an adults each week. As a staff, we meet three to four times per year to plan for the year's activities. The children continue to bring offering each Sunday and in 2012, we used our funds to support Presbyterian World Service and Development programs and Camp Douglas.

We are continuing our monthly Sunday School Teachers' Prayer meetings on the first Sunday of each month. All congregation members are welcome and our purpose is to pray for the needs of the Sunday School and the church and to praise God for his attributes and his blessings. Usually six to eight people attend and it has been wonderful to see how God answers our prayers. We hope that more people will join us in 2013.

Our registration from preschool to College and Career classes was fifty six students. We also had one adult class of six participants. Our weekly attendance from preschool to adult classes was about fifty to sixty members.

In our preschool to primary department, we are continuing with our Centers' approach in teaching our students. They really enjoy moving from center to participate in a variety of activities including Bible story, crafts, lesson follow-ups, games, singing and monthly birthday acknowledgements.

In September, 2012, the Grade 2/3 class was given an opportunity to learn the recorder. Instead of doing a craft activity, the students learned to play the recorder. God enabled me to work with these students for twenty minutes every Sunday and they were able to perform two songs, "Jingle Bells" and "Ode to Joy" at our Christmas and Candlelight services. In addition, we discovered other musical talent among our Sunday School students. We were able to form a string ensemble composed of two violinists, two cellists, two flautists and one pianist who performed at the Thanksgiving, Christmas and Candlelight services. Also, we had several younger children play Christmas carols on the piano.

The Sunday School students participated in the following events this year:

- April 8th Easter Sunday Preschool to Grade three students performed songs and recited Bible verses in the English worship service; Easter Celebration Easter egg hunt, magic show, children's thought and refreshments
- May 13th Mothers' Day Preschool to Grade three students sang songs and students performed solos on the violin and piano; Students also passed out flowers to all the mothers

- June 17th Fathers' Day Preschool to Grade three students sang songs and students performed solos on the violin and piano; Students also passed our pens to all the fathers.
- July 16th 20th Vacation Bible School Both Sunday School Teachers and students who participated were involved as attendees, helpers or teachers.
- Sept. 9th Rally Sunday
- Sept. 23 Recorder program began for Grades 2/3 students
- Sept. 30th Sunday School Teachers' Appreciation Lunch
- Oct. 7th Sunday School students from preschool to Grade 6 participated in the service. We wanted to the students to be a part of the worship service experience. The students were involved in greeting, taking the offering, singing, choral reading, piano solos and string quartet ensemble.
- Dec. 23rd Sunday School students from preschool to Grade 6 participated in the service as they did at Thanksgiving with the addition of the recorders.
